

# PRIVACY POLICY

This Privacy Policy applies between you, the User of this Website, and Mirage Maker AI Ltd, the owner and provider of this Website. Mirage Maker AI Ltd takes the privacy of your information very seriously. This Privacy Policy applies to our use of any and all Data collected by us or provided by you in relation to your use of the Website.

**Please read this Privacy Policy carefully.**

## Definitions and Interpretation

1. In this Privacy Policy, the following definitions are used:

<b>Data</b>	collectively all information that you submit to Mirage Maker AI Ltd via the Website. This definition incorporates, where applicable, the definitions provided in the Data Protection Laws;
<b>Cookies</b>	a small text file placed on your computer by this Website when you visit certain parts of the Website and/or when you use certain features of the Website. Details of the cookies used by this Website are set out in the clause below ( <b>Cookies</b> );
<b>Data Protection Laws</b>	any applicable law relating to the processing of personal Data, including but not limited to the GDPR, and any national implementing and supplementary laws, regulations and secondary legislation;

<b>UK and EU Cookie Law</b>	the Privacy and Electronic Communications (EC Directive) Regulations 2003 as amended by the Privacy and Electronic Communications (EC Directive) (Amendment) Regulations 2011 & the Privacy and Electronic Communications (EC Directive) (Amendment) Regulations 2018;
<b>User or you</b>	any third party that accesses the Website and is not either (i) employed by Mirage Maker AI Ltd and acting in the course of their employment or (ii) engaged as a consultant or otherwise providing services to Mirage Maker AI Ltd and accessing the Website in connection with the provision of such services; and

- c. a reference to a person includes firms, companies, government entities, trusts and partnerships;
- d. "including" is understood to mean "including without limitation";

- e. reference to any statutory provision includes any modification or amendment of it;
- f. the headings and sub-headings do not form part of this Privacy Policy.

## **Scope of this Privacy Policy**

- 3. This Privacy Policy applies only to the actions of Mirage Maker AI Ltd and Users with respect to this Website. It does not extend to any websites that can be accessed from this Website including, but not limited to, any links we may provide to social media websites.
- 4. For purposes of the applicable Data Protection Laws, Mirage Maker AI Ltd is the "data controller". This means that Mirage Maker AI Ltd determines the purposes for which, and the manner in which, your Data is processed.

## **Data Collected**

- 5. We may collect the following Data, which includes personal Data, from you:
  - a. name;
  - b. date of birth;
  - c. gender;

  - f. explanation of what the user wants on the portrait in text form;in each case, in accordance with this Privacy Policy.

## **How We Collect Data**

- 6. We collect Data in the following ways:
  - a. data is given to us by you; and
  - b. data is collected automatically.

## **Data That is Given to Us by You**

- 7. Mirage Maker AI Ltd will collect your Data in a number of ways, for example:
  - a. when you contact us through the Website, by telephone, post, e-mail or through any other means;

  - c. when you make payments to us, through this Website or otherwise;

11. When you register with us and set up an account to receive our services, the legal basis for this processing is the performance of a contract between you and us and/or taking steps, at your request, to enter into such a contract.

  - a. third party service providers who provide services to us which require the processing of personal data - So that the physical canvas can be shipped to the address of the user;in each case, in accordance with this Privacy Policy.

## **Keeping Data Secure**

13. We will use technical and organisational measures to safeguard your Data, for example:
  - a. access to your account is controlled by a password and a user name that is unique to you.
  - b. we store your Data on secure servers.

## **Data Retention**

17. Even if we delete your Data, it may persist on backup or archival media for legal, tax or regulatory purposes.

## Your Rights

18. You have the following rights in relation to your Data:
  - a. **Right to access** - the right to request (i) copies of the information we hold about you at any time, or (ii) that we modify, update or delete such information. If we provide you with access to the information we hold about you, we will not charge you for this, unless your request is "manifestly unfounded or excessive."   - e. **Right to data portability** - the right to request that we move, copy or transfer your Data.
  - f. **Right to object** - the right to object to our use of your Data including where we use it for our legitimate interests.
